Hello,

I wanted to let you know that HB20-1333, Homeowners' Association Transparency Responsibility Competency, was postponed indefinitely (died in committee). Also, HB20-1200, Sunset Homeowners' Association Information And Resource Center, was stripped of the controversial portions, and all that remains is the continuation of the HOA Resource and Information Center and HOA Information Officer.

I want to emphasize the critical importance of you making your opposition known on these bills. It was a key factor in the results that we saw yesterday. These were special

circumstances this year, so we can expect both bills to come back in 2021 and need to be prepared to fight them.
